1. I/we have read the terms and conditions below and agree to abide by them in full
 - a) 'The Act' shall mean a solo artist or a musical group collectively, or disc jockeys.
 - b) 'Venue' shall mean a place of public performance and its proprietor(s) and/or their servants/agents which have engaged Central Entertainment Bureau Limited (hereinafter referred to as CEB) to provide live entertainment and 'Venues' shall have the corresponding meaning.
2. This condition applies to musical groups, solo acts and disc jockeys.
3. CEB shall have the right to engage the Act to perform at Venues. The Act shall not engage in any discussion, correspondence or negotiation with any Venue (as defined above) otherwise than through CEB, where CEB represents that venue. Should CEB cease dealing with that venue, a period of 6 months MUST elapse before the act is able to deal directly with that venue, if approached by same.
4. Payment for the performance shall be agreed in advance with CEB. Payment shall be made by **electronic transfer** into the Act's bank account on the **10th of the FOLLOWING MONTH**. Bank details to be provided for each and every account nominated by the act.
5. The Act will supply fifteen promotional posters to CEB at least three weeks prior to a performance.
6. The Act (or in the case of a musical group, the Appointed Member) will contact CEB on the Tuesday before a performance is due to take place to confirm arrangements for the performance. Failure to do so may result in cancellation.
7. When performing, the Act shall:
 - a) perform for a minimum of 120 minutes;
 - b) conduct itself in a mannerly fashion;
 - c) refrain from using bad language during the course of the performance;
 - d) not be intoxicated; and
 - e) remove its equipment from the Venue immediately after the performance unless otherwise agreed.
8. Where the Act cancels or fails to provide a performance, the Act shall pay a financial penalty equivalent to the agreed payment except in case of inability to perform due to illness evidenced by an original Doctor's Certificate. In such circumstances, CEB may request that the artist in question attend a general practitioner nominated by CEB for medical examination / treatment.
9. CEB shall not be responsible for any loss suffered by the Act where a Venue cancels a performance. Without prejudice to the foregoing, in such circumstances, CEB will endeavour to make alternate arrangements (i.e. arrange a performance elsewhere) or to obtain a cancellation fee from the Venue for the Act if possible.
10. The Act shall be responsible for making of all statutory deductions and the payment of all taxes (whether income tax, VAT or otherwise) in relation to monies paid on foot of this contract. NO SUCH DEDUCTIONS shall be made by CEB from payments.
11. The Act hereby permits CEB to use its name for the purposes of promoting performances, allowing CEB to list the act on any printed matter and its website for marketing purposes; and agrees to accept sole responsibility in the event of any complaint or dispute arising therefrom. Without prejudice to the generality of the foregoing, the Act hereby agrees to indemnify CEB against any claims howsoever arising concerning advertising, copyright, the tort of 'passing-off', litter and defamation.
12. For a period commencing four weeks before and ending four weeks after the date of a performance, the Act shall not perform within a 1-mile radius **or** in venues that are in direct competition with the Venue.
13. No warranty or representation is made concerning the state of repair or condition of the Venue. Therefore, the Act and associated personnel shall be responsible for their own personal safety and insurance. In the event of any injury, loss or damage caused to the Act, the Venue, any third party or any property, CEB shall not be liable in relation to any claim arising there from.
